Stolen at Noumea, New Caledonia, from the steamer Lord Ashley, while on her passage from Noumea to Sydney, between the 21st and 27th ult., the property of Anna Bauer, a passenger at present residing at No. 149, Castlereagh Street, Sydney,—A pair of gold earrings, a large diamond in centre with small ones round; a gold ring with a diamond set in square of black enamel; a gold ring, snake pattern with turquoise head and diamond eyes; a gold ring, round cameo with an anchor, a cross, and a heart engraved on it; a gold ring set with turquoise, in shape of a flower; a pair of large round gold earrings, with gold bars through, and black stones at top; a pair of earrings, brooch and sleeve links of pink coral; an oval brooch enamelled and set with pearls, a painting in centre representing a shepherd and shepherdess; a large size gold watch, plain; a large size old fashioned gold watch, enamelled green; a long narrow brooch with round jasper in middle, and pearl in centre; a bracelet three or four fingers wide, plain gold top, and a bar of pink coral held by a ring surrounded with diamonds; a chain shaped bracelet, very heavy, with jasper locket attached, on which are engraved the letters "A.B." a gold bracelet engraved and set with a large amethyst, surrounded by smaller ones and pearls; a gold bracelet, two gold watch keys, one large set with a ruby; an oval scarf ring opens with a spring; a small oval brooch set with rubies; two gold pencil cases; a gold necklace set with pink coral, with a cross in which are 8 pieces of pink coral; a coral necklace and cross, a gold necklace with large cross, set with turquoise and rubies; a pair gold sleeve links set with round amethysts, and a diamond flower in centre; two very fine chains passed through a gold ring, a gold chatelaine with three chains, one of which is incomplete; a gold locket, opens on one side, hair inside; an eyeglass silver gilt, attached to a chain with a hook at the end; a ring with small pearls forming a cross with a diamond in the centre, and supposed to have a ruby at each end, and a ring in black hair plaited at top, two claws in gold in the middle; a small gold seal, engraved but without letters, but supposed to have a date in it; and a pocket knife with a corkscrew with other implements in it. \$3500 REWARD.

OSCAR WALTER (Ossip Ivanovitch Walter), was a broker in Moscow, Russia, and left there about the 14th November, 1875, with a Russian passport signed by the Governor General of Moscow, bearing date of September 2nd, 1875 (Russian Calendar). After his departure, it was ascertained that he had committed forgeries to the amount of over 300,000 Roubles, thereby victimizing several banks and individuals in the empire of Russia. He is supposed to be now in the American Continent. \$3500 REWARD.

OSCAR WALTER (Ossip Ivanovitch Walter), was a broker in Moscow, Russia, and left there about the 14th November, 1875, with a Russian passport signed by the Governor General of Moscow, bearing date of September 2nd, 1875 (Russian Calendar). After his departure, it was ascertained that he had committed forgeries to the amount of over 300,000 Roubles, thereby victimizing several banks and individuals in the empire of Russia. He is supposed to be now in the American Continent. Description—about 35 years of age; above the medium height; walks erect; is of rather pale complexion; high forehead; hair brushed back and thin on top of head; grey eyes; large nose; wore moustache and beard clipped short, but on leaving Moscow, had only a moustache, which was tinged with grey on one side; dresses neatly; is Russian by birth, but probably speaks fluently German, French, and other languages. Marks—Anchor and J right arm; sailor and mermaid left arm; a carpenter; has a spot size of half crown on left side of head void of hair; has been in Royal Navy; an Englishman; walks with a quick short step, turns right foot outward. Absconded from Convict Boat Party, Fremantle, on the 16th December, 1870, and is believed he went overland to South Australia with Bernard Stein in October, 1874.

5. JAMES BAKER, Reg. No. 9068, Imperial Convict; arrived in the Colony per convict ship Corona, 1866, under sentence of 15 years p.s., 25th March, 1865.
