Stealing in Dwellings, from the Person, &c.

Vide C.I. 324, 1876.

Two sets of horse shoes therein described have been recovered, and identified by Nathaniel Reeder. These shoes were put on horses belonging to James Cunningham, of Woonganine, by Henry Dover, exp., late 745. The other shoes stolen are supposed to have been planted in the bush. *Vide Apprehensions.*

On 10th ult., Patrick Keenan left a pair of trousers rolled up in a flour sack in the hut of James Payne, exp., late 1696, about five miles from Albany; in the pocket of the trousers was a purse containing £14; on 11th Keenan took away the trousers but did not examine the purse until the 14th ult., when he found five sovereigns were missing.—C.I. 33.

On night of 1st inst., from the yard of Messrs. Padbury & Co., Perth, their property,—a horse's head collar, new; throat lash attached. James Stevens, free, of York, suspected.—C.I. 34.

On night of 1st inst., from the yard of Messrs. Padbury & Co., Perth, from the person of James Stevens, of York,—16s. or 17s. in money, knife and tobacco; the pocket had been cut. *This robbery is reported by Perth Police as very doubtful, and is thought to be an attempt to throw suspicion off about the head collar.*—C.I. 35.

On or about 20th ult., from dwelling house of Mary Ann Tapper, Fremantle,—pair woman's cotton drawers and cotton chemise. Chemise since recovered, found on Margaret Houlahan. *Vide Apprehensions.*—C.I. 36.

On night of 21st ult., from the shop of William Robinson, of Newcastle,—carpenter's brace, two bits, several iron drills, and new half-round file.—C.I. 37.

Stealing in Dwellings, from the Person, &c.

On 11th inst., from a box in the bedroom of John Butcher's dwelling house, Murray Street, Perth,— $\frac{1}{2}$ lb. fancy biscuits.—C.I. 39.

Since 25th July, 1876, from a box, supposed while on transit from Esperance Bay to Fremantle, the property of Robert Mansfield, late of "Mary Ann," schooner, now of Perth,—Medicine chest, containing weights and scales and several surgical instruments, also several bottles of medicine. Chest was about 18 inches by 7 or 8 in. wide, and about 9 in. deep. Also several receipts, one being for 4,500 dollars, signed Charley Smit, Shanghai; several flannel shirts (white), and two medical works containing plates; both books have the name of Phillips in several places.—C.I. 40.

On 3rd inst., from the house of Samuel Hatten, about six miles from the Vasse,—two white shirts, two striped Crimean shirts, two pair drill trousers, one pair moleskin trousers, dark tweed pair of trousers, white coat, new brown hat, pair elastic-side boots, four white handkerchiefs, and a purse containing 37s. in silver. A native named Coregood suspected.—C.I. 41.

From the person of Henry Vicary, at the house of James Atkinson, Murray Street, Perth, on the night of the 10th inst.,—piece of beef about 11 lbs., bottle of rum, and about £1 17s. in silver. *Vide* Apprehensions.—C.I. 42.

On 6th inst., from the person of Thomas Walton, while lodging at the Horse & Groom Hotel, Perth,—four £1 notes, Nos. or Bank not known, about 17s. in silver, and two thimbles.—C.I. 44.
