Stealing in Dwellings, from the Person, &c.

About two months ago, from the homestead of Henry Martin, of Chittering Brook,—6 black barrow pigs, about 3 years old, one had a little white across breast, tips of right ears cut off; one had a small sized sheep bell fastened on with a strap.—C.I. 142.

The dog therein described has been recovered, and warrant issued for arrest of George Williams, exp., late 8615. *Vide* Warrants Issued.

On night of 22nd ult., from the premises of Amos Bradshaw, York,—about 30lbs. of salt pork.—C.I. 143.

On night of 23rd ult., from the premises of H. L. Davis, York,—full grown turkey cock.—C.I. 144.

On 27th ult., from the stable of Samuel Martin, of Cole Harbor, York District,—one winker bridle, one pair of shaft hames, pair of plough traces; the buckle of hames strap sewn with twine.—C.I. 145.

Between the 16th and 19th ult., from the dwelling house of David Forrest, of Youndegin,—about 3lbs. sugar and one tin tea canister. Ab. native Jiaher committed this robbery.—C.I. 146. *Vide* Apprehensions.

Also from the hut of Jacob Jacobson, same date, between Jarrahdale and Rockingham,—4lbs. sugar, 4lbs. bacon, $\frac{1}{2}$ lb. tea, one opossum skin rug, untanned, the third skin from one corner torn, and a piece cut out of another corner, about 4in. in diameter. Thos. Smith, exp., *alias* Brocky Tom, suspected, as he was seen about the huts that morning.—C.I. 149.
