## Circular Orders and Miscellaneous Information.

C.O. <sup>6</sup>/<sub>554</sub>.—It having been brought to the notice of His Excellency the Governor, by several settlers, that the dogs belonging to natives in some Country Districts of the Colony are committing serious depredations amongst their flocks and herds, the police throughout the Colony are hereby directed to enforce the provisions of the 10th Vict., No. 5, stringently.

Should it be reported to the police at stations, or while patrolling districts, that the dogs belonging to natives are committing depredations, they should at once apply under the 3rd section of the above Act to the nearest Justice of the Peace for authority to destroy them.

Officers in charge of Districts will see that the above Order is strictly enforced.

Monthly reports to be made of any action taken under this Act.
