The schooner was sold by them to Joshua Woods, of Roebourne, for £50, and is now used in the Pearl Fishery, on the N.W. Coast. Groat and Kelly sailed from Port Walcott, N.W. Coast, in the schooner "Subahani," on the 24th May last, bound to Maccassar; Groat shipped as Mate, Kelly, A.B. *If the "Subahani" puts in at any Port in W.A., police to ascertain quietly if either of these men are on board, and report to Detective Office, Perth.*
