HIS Excellency the Governor has been pleased to direct that from and after the 1st January next the conveyance of the Mails between Perth and the Eastern Districts, and between Perth and the Southern Districts, be conducted by the Police Department. The services will, as heretofore, be bi-weekly, and the Mails will be carried along the following routes, viz. :—

- 1st.—Between Perth and Northam, *via* Guildford, Lakes, and York, and *vice versa*.
- 2nd.—Between Perth and Northam, *via* Guildford, Baylup, and Newcastle, and *vice versa*.
- 3rd.—Between Perth and Vasse, *via* Narrogin, Serpentine, Pinjarrah, Harvey, Australind, and Bunbury, and *vice versa*.

Detailed information as to the arrival and departure of the Mails from the General Post Office, and the various Post Offices on the respective routes, will be found in the Time Tables published by the Acting Postmaster General and Superintendent of Police in today's *Gazette*.

Passengers and parcels will be booked at any of the Post Offices and Police Stations on the before-mentioned routes, and the following will be the scale of charges :—

Circular Orders and Miscellaneous Information.

C.O. ^o/₆₀₄.—From and after the 1st February, 1880, the following Regulations will come into force with respect to the Perth and Albany Royal Mail Service:—

The Royal Mail Coach with the Colonial Mails will leave Perth for Albany twice a month, and will return with the English Mails. Date and time of departure of Mail from Perth will be notified by the Postmaster General.

The horses (excepting those at Albany) will receive the full allowance of forage while the coach is travelling, on the same principle as at present, and a two-third allowance for the remainder of the time.

The horses at Albany will receive the full allowance of forage throughout the year.

The fixed establishment of the horses of the Royal Mail Service will be thirty-six, being nine relays of four each, and stationed as shown in the attached list.

The horses at Albany will, as at present, be forwarded to Chockerup, on the departure of the Mail Coach from Perth.

The horses on the fixed establishment of the Mail Service are not to be used for any other purpose.

There will be a certain number of spare horses distributed among the Stations, as shown in the attached list.

The forage issued to them will be chargeable to the Police Department, and these, with the horses of the fixed establishment of the Police Department, are to be made available for Mail purposes whenever necessary and on any emergency.

The forage issued to the spare horses at the 131-mile Station and the Gordon Station will be chargeable to the Mail Department. When there is feed in the paddocks the spare horses are to receive only half forage allowance; and when there is no feed a two-third allowance; when being worked they are to receive the full allowance.

Separate forage books are to be kept for the fixed establishment of horses belonging to the Royal Mail Service, and separate monthly returns forwarded as at present.

C.O. ^{6/1005}.—The attached General Order concerning the establishment of a Royal Mail Service, conducted by the Police Department, for conveyance of Mails between Perth and the Eastern and Southern Districts, is published for the information of the Police throughout the Colony, and for the special guidance of the Police at the Stations named in the margin.

In connection with the Mail Service there will be four drivers, stationed at the following places:—
Two at Perth, one at Guildford, and one at Vasse.

One driver at Perth will drive between Perth and Northam, *via* Guildford, Lakes, and York; and the other between Perth and Pinjarrah, *via* Narrogin and Serpentine.

The driver at Guildford will drive between Guildford and Northam, *via* Baylup and Newcastle.

The driver at Vasse will drive between Vasse and Pinjarrah, *via* Upper Capel Bridge, Bunbury, Australind, Brunswick, and Harvey.

It will be the duty of the drivers to look after the Mail Coaches, Horses, Harness, and other articles issued for Mail Service at their respective Stations.

The salary of each driver will be six shillings per diem, and each will be supplied with a suit of Uniform, Great Coat, and Waterproof Coat.

Each driver will be sworn in as a Police Constable.

There will also be a Native Assistant at the Stations named in the margin, to assist in looking after the Mail Horses.

The allowance for their maintenance will be £30 per annum, and each native will be supplied with a suit of clothing and a rug.

Special arrangements have been entered into at Baylup with Mr. Donegan; at Narrogin with Mr. Saw; and at the Serpentine with Mrs. Turner, for looking after the Mail Horses to be stationed at their places; and with Mr. Leeder at Northam, for looking after the Mail Coaches and Horses on arrival there.

The Horses for the Mail Service will be stationed as shown in the attached list.

They are to receive the full daily allowance of forage throughout the year (18lbs. hay and 9lbs. corn).

Separate Forage Books for Forage issued to Mail Horses are to be kept at each Station, and separate Forage Returns forwarded monthly to the Chief Office.

The Caretaker at the Lakes Station will keep the usual Forage Book, and forward monthly Forage Returns, to the Chief Office through the Sergeant in charge of the York Sub-district.

A supply of stable utensils and other stores will be forwarded to each Mail Station, and a monthly return of such articles is to be forwarded to the Chief Office.

The Police on the different Stations on the Mail Route are to render every assistance to ensure the proper conduct of the Mail Service, and the utmost civility is to be shown on all occasions to all persons travelling by the Mail Coaches.

The Sub-district Officers are, by frequent inspection, to satisfy themselves that the Mail Horses in their Sub-districts are properly looked after.

Any irregularities are to be reported at once.

The Inspector of Police of the Southern District will also make it a point of periodically inspecting such of the Mail Stations as are in his District, and reporting thereon.

The Baylup Mail Station will be in the Newcastle Sub-district.

The Lakes Mail Station will be in the York Sub-district.

The Narrogin Mail Station will be in the Perth Sub-district; and the Serpentine Mail Station in the Fremantle Sub-district.

All correspondence connected with the Royal Mail Service is to be forwarded to the Chief Office under separate cover.
