## Circular Orders and Miscellaneous Information.

C.O. <sup>9</sup>/<sub>25</sub>.—It has come to the knowledge of the Superintendent of Police that certain members of the Police Force are in the habit of treating persons who come to the Police Station, or who seek information from them on other occasions, in a curt and off-handed manner.

The Superintendent is confident that such behaviour is not a rule in the Police Force, but with a view to at once checking conduct which is apt to bring the force into bad odour, and as a caution to those who have been guilty of it, he desires to make it known, that should any instance of incivility on the part of any member of the force to any person whatsoever, be brought to his knowledge, he shall be compelled to take very serious notice of it.

The utmost civility is to be shown by the members of the Police Force, at any time or place whatsoever to all persons seeking information, asking advice, or wishing to lay charges.

There is nothing conduces so much to the credit of a Police Force as civility and smartness on the part of its members.

Inspectors and all officers in charge of Stations are directed to bring to the notice of the Superintendent of Police any infringement of the above order.

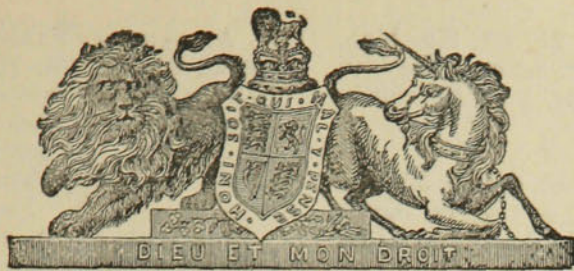

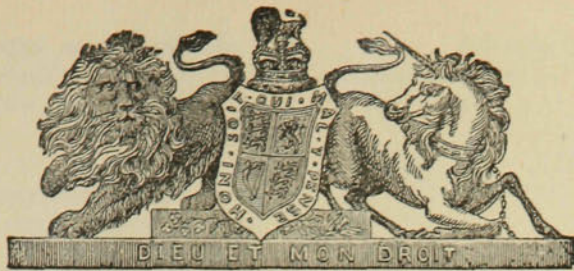
