C.O. ⁶/_{55A}.—The Superintendent of Police directs that for the future every Constable, foot or mounted, when on duty, shall carry a Memorandum Book, in which is to be entered legibly, neatly, and concisely, the time and date of any important occurrence that may come under his notice, as well as any particulars connected therewith that it would be important for him to remember in giving evidence. Also the names or descriptions of suspicious characters, thieves, &c., and time when and place where seen—the result of inquiries he may be sent to make. Reports of thefts, lost property, &c., by whom made, when and where, and any clue he may have obtained—in fact anything that it may be his duty as a Police Constable to note and report.

Mounted Constables when proceeding on duty to the bush should also enter any extracts from the Police Gazettes relative to absconders, robberies, &c., that may be of service to them.

All entries should be made, if possible, at the time of the occurrence to be noted, or as soon as possible afterwards.

These Memorandum Books are to be handed in at the Police Station on the return of the Constables from duty, to be inspected and initialled by the officer in charge, and are to be kept at the station and ready for inspection at any time by the Superintendent or the Inspectors.

A supply of Memorandum Books can be obtained from the Chief Office on requisition.

Each book is to have the name of the Constable to whom it is issued written on the first page, and no private memoranda are to be entered therein.
