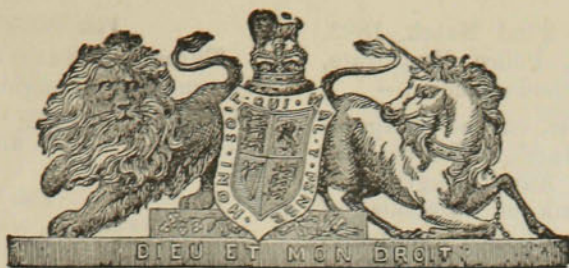

Beaumont;" cheque drawn on the Union Bank of Australia, Perth, for £5,300, signed "Charles Beaumont;" two cards with "Sir F. W. Beaumont, South Australian Club Hotel, Adelaide," written on them, three cards with "Mr. F. W. Beaumont" written on them: Photograph No. 33972, taken at Ballarat, Victoria, by Bardue & Co., "Miss E. C. Young, 17th March, 1881," written on it. Beaumont arrived in this colony on the 23rd February, 1882, by the *s. s. Macedon*, from Adelaide, and was described as an American novelist. Description—Small man, age 25, slight build, about 5 feet 5 inches high, light complexion and hair, rather weak eyes, very light downy moustache, shaves on chin, wears whiskers high up sides of face, stoops slightly at shoulders, either is or appears so deaf that one has to talk in a loud voice to make him hear, has a small squeaky voice, speaks good English, but with a very strong American intonation; states he was born in the island of "Crete," while his parents were on their way to India, in the year 1857; that he took the degree of B.A., at Trinity College, Dublin; he got married at 17 years of age and was left a widower when he was 21; he has one child; was a member of the City Carlton Club, London, states he was a lawyer and has had considerable practice at the bar. States his estates are in Cumberland; he has travelled in America, but now pretends not to know much about it; been living in Australia nine months; has a large station with hundreds of horses on it at Mittagong; says he is well known to Mr. and Miss Bansfield, who keep a school at or near Moss Vale, and that a creek named Ulong runs at the end of his station; that he has also a sheep station in South Australia, named Yanyarie, in the hundred of Yanyarie, about nine miles from Willochra; says he has never been in Melbourne; also states that he has three yachts on the way here, but did not exactly know whether he would have them come into Fremantle or not, he thought the port dues were too heavy; the largest yacht is 124 tons, fore and aft schooner, carries nine hands; he has about £500 worth of champagne in her; the second one is nine tons with another crew; the third one is two-and-a-half tons and is carried on board the large one; states he has engaged another captain in Adelaide besides the one that brought the large yacht from England, one who knows this coast; he keeps these yachts because he is so passionately fond of the sea. Beaumont was on the 8th inst. committed for trial on two charges.

C. Young, 17th March, 1881," written on it. Beaumont arrived in this colony on the 23rd February, 1882, by the s. s. *Macedon*, from Adelaide, and was described as an American novelist. Description—Small man, age 25, slight build, about 5 feet 5 inches high, light complexion and hair, rather weak eyes, very light downy moustache, shaves on chin, wears whiskers high up sides of face, stoops slightly at shoulders, either is or appears so deaf that one has to talk in a loud voice to make him hear, has a small squeaky voice, speaks good English, but with a very strong American intonation; states he was born in the island of "Crete," while his parents were on their way to India, in the year 1857;

that he took the degree of B.A., at Trinity College, Dublin; he got married at 17 years of age and was left a widower when he was 21; he has one child; was a member of the City Carlton Club, London, states he was a lawyer and has had considerable practice at the bar. States his estates are in Cumberland; he has travelled in America, but now pretends not to know much about it; been living in Australia nine months in New South Wales; has a large station with hundreds of horses on it at Mittagong; says he is well known to Mr. and Miss Bansfield, who keep a school at or near Moss Vale, and that a creek named Ulong runs at the end of his station; that he has also a sheep station in South Australia, named Yanyarie, in the hundred of Yanyarie, about nine miles from Willochra; says he has never been in Melbourne. He has in his possession a Title Deed under Sec. 20, Land Act, 1869, of the Colony of Victoria, entered in the Register Book, Vol. 372, Fol. 74358, belonging to Thomas Murphy, of Sale, farmer, containing 17 acres 14 perches, more or less, with Beaumont's writing on back, purporting to be a transfer of the said land, written and witnessed "Wm. Robertson," also in "Beaumont's" hand writing, dated 3rd December, 1881. Had a letter on him in his own writing addressed to "Messrs. Gunsler, Chambers, & Co., S.A. Club Hotel, Adelaide," purporting to be from the "Hon. Frederick Beaumont, Bt., of Holmwood Hall, Cumberland, England (travelling incog.), dated Fremantle, 27th March, 1882," informing them of his intended arrival in South Australia shortly, and signed "Roger Mortimer, Private Secretary;" also states in one of his letters that he has been a clerk for the last four years to a New South Wales Attorney; also states that he has three yachts on the way here, but did not exactly know whether he would have them come into Fremantle or not, he thought the port dues were too heavy; the largest yacht is 124 tons, fore and aft schooner, carries nine hands; he has about £500 worth of champagne in her; the second one is nine tons with another crew; the third one is two-and-a-half tons and is carried on board the large one; states he has engaged another captain in Adelaide besides the one that brought the large yacht from England, one who knows this coast; he keeps these yachts because he is so passionately fond of the sea. Beaumont was on the 8th inst. committed for trial on two charges.
