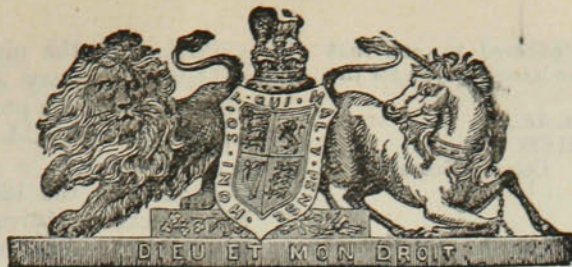

Circular Orders and Miscellaneous Information.

C.O. ⁶/₇₀₇.—The Superintendent desires to draw the particular attention of the Police throughout the Colony to the Circular Orders, printed hereunder, issued from time to time, respecting the treatment of native prisoners while being escorted, and to impress on the Police the necessity of adhering strictly to the instructions contained in these orders.

2. The practice of chaining native prisoners by the neck is strictly forbidden, except under the special circumstances mentioned in C.O. ⁶/₅₅₈, of the 19th July, 1878, and under no circumstances is the chain to be attached to the saddle, or to the horse.

3. Native prisoners on board ship are not to be chained together.

4. The Superintendent is well aware that escorting native prisoners, especially in the bush, is a very trying duty, requiring the exercise of great vigilance and patience; but the Police must remember that, while adopting such precautionary measures as are actually necessary to ensure the safe custody of native prisoners on these occasions, it is their duty always to treat native prisoners with proper consideration and humanity.

5. Any violation of the above instructions will render the offending constable liable to immediate dismissal from the Force.

SIR,—I am instructed to inform you that it has come under the notice of the Governor, that when aboriginal native prisoners are under escort of the Police, the chain attached to the prisoner is fastened to the horse on which the Police Constable is mounted.

I am directed by His Excellency to request that you will have positive orders issued to the members of the Police Force, that under no circumstances is the chain of the native prisoner to be fastened to the horse: it must be held in the hand of the Police Constable.

Officers in charge of Divisions will issue positive orders, that under no circumstance is the chain of the native to be fastened to the horse, but must be held in the hand of the constable.

The Superintendent directs that for the future the practice of escorting native prisoners chained by the neck shall be discontinued, except in the case mentioned below.

When found necessary in escorting native prisoners, they should be chained together by their waists, one hand being handcuffed or fastened to the chain, the end of the chain being held in the constable's hand, but on no account to be fastened to the horse or the saddle.

If there is only one prisoner, he should be secured in a similar manner, unless a handcuff on the wrist is found sufficient.

This order does not apply to the escorting of native prisoners (especially those of a desperate character) arrested at considerable distances in the bush, when it may be necessary to adopt special measures to secure them; but even then, the practice of chaining by the neck should not be resorted to if it can be avoided.

In all cases when the escort has to camp out for the night or halt in the bush for any time, native prisoners should be invariably chained by the leg.

OPINION.

The Commission are of opinion that the practice of chaining native prisoners by the neck should not be resorted to except in special circumstances, such as travelling through the bush, or by sea when near land to which the prisoners belong, or in the case of refractory prisoners; that Circular Orders,

No. $\frac{6}{444}$ of 16-10-75,
No. $\frac{6}{558}$ of 19-7-78,
No. $\frac{6}{649}$ of 25-1-82,

should be carefully adhered to by the police; whilst, as regards the jails in securing native prisoners, the practice of chaining by the neck should be discontinued.

Should it be deemed necessary to resort to chaining in any way in prison, the Commission recommend that handcuffs or leg chains be used, and that the Sheriff be advised to this effect.
