Roebourne.—On the 13th December last, the remains of a human being were found under a small snake-wood bush—the only tree on a large plain—about 60 miles West of Roebourne; about 3 miles from the Government well on the Ashburton road. Result of inquiries made by P.C. Guilfoyle showed that the remains were very much bleached and strewn about, no trace of clothing or any other property being in the vicinity. The remains, which are supposed to be those of a Chinaman who absconded from the service of Mr. Woolhouse 3 or 4 years ago, were buried on the spot by P.C. Guilfoyle.

Roebourne.—On the 6th December last an inquiry was held by the Roebourne Police respecting the cause of death of Henry Simpson, a man about 45 years of age, who was employed at Nanutana Station, and died there on the 29th October last after a short illness. Result of enquiries proved that the deceased died from natural causes.

Roebourne.—On the 11th ult. inquiries were instituted by the Roebourne Police respecting the cause of death of Andrew Kavanagh, a man about 60 years of age, who originally came overland from Queensland to Kimberley, and who was found by Roderick Mackay, of Yule, lying dead in an old hut

at Peewah on the 8th ult. Result of inquiries indicated that the deceased had lost his way and perished from thirst and from drinking water from the salt pool at Peewah. Property found on deceased was about 2 ounces of gold and 9s. in silver. 2 horses which had been in possession of the deceased were found dead, having been bogged in the marsh.
