Circular Orders and Miscellaneous Information.

C.O. $\frac{2}{9}$.—The attention of members of the force who have occasion to issue requisitions for supplies or services is directed to C.O. 6/924 of the 9th May, 1890, which is not so closely followed as it should be. Its provisions must be faithfully observed for the future. Officers in charge of districts are required, before forwarding accounts, to see that they are prepared in accordance with that order.

In many instances it is found that accounts are not submitted so promptly as they should be, and members of the force are reminded that it is their duty, so far as practicable, to see that in all cases the vouchers are promptly signed and sent in by public creditors. The accounts are to be transmitted to the Chief Office by the officers in charge as soon as they are received. Only those which are received at the Chief Office on or before the 26th of each month can be passed for payment with the month's accounts. It is desirable that as many as possible of them should be in hand before that date, so as to allow of any explanation or amendment that may be required being made.

Accounts for medical attendance upon members of the force must show the nature of the illness from which they have suffered, the period over which the attendance has extended, and the number of visits it embraces.

In the column for "Particulars," on the face of all accounts, and also in the requisition, must be entered the name of the station at which the supplies have been obtained or the service has been performed.

In signing "Travelling Forage Vouchers" members of the force must be careful to insert the place at which the forage is obtained, and must also show the number of feeds it makes and the period for which the supply was required. As for example: "One day and night, 4 mixed feeds; from 12 noon, 18th July, to 12 noon, 19th."

Officers in charge of districts are expected to see that the foregoing instructions are implicitly obeyed.

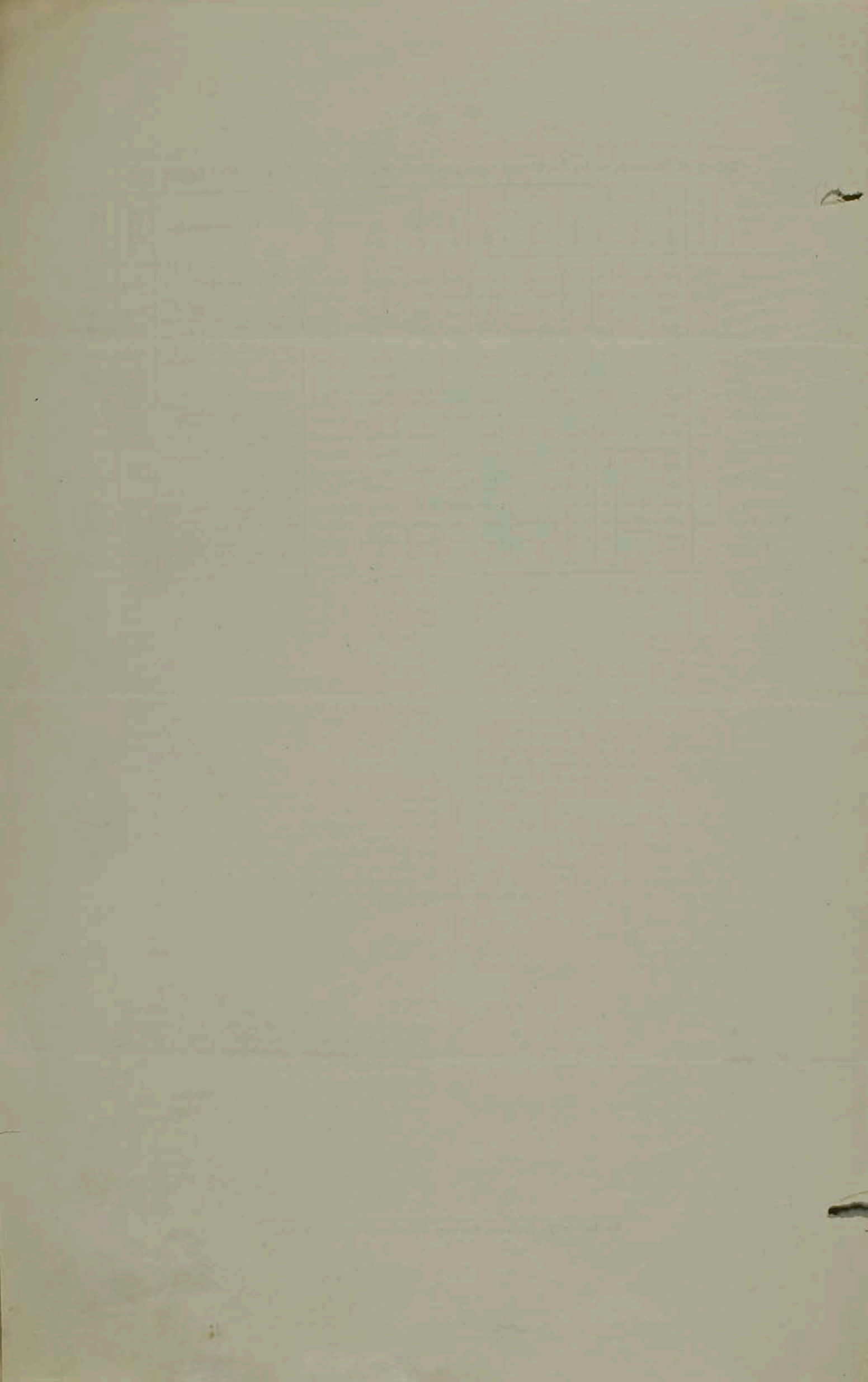

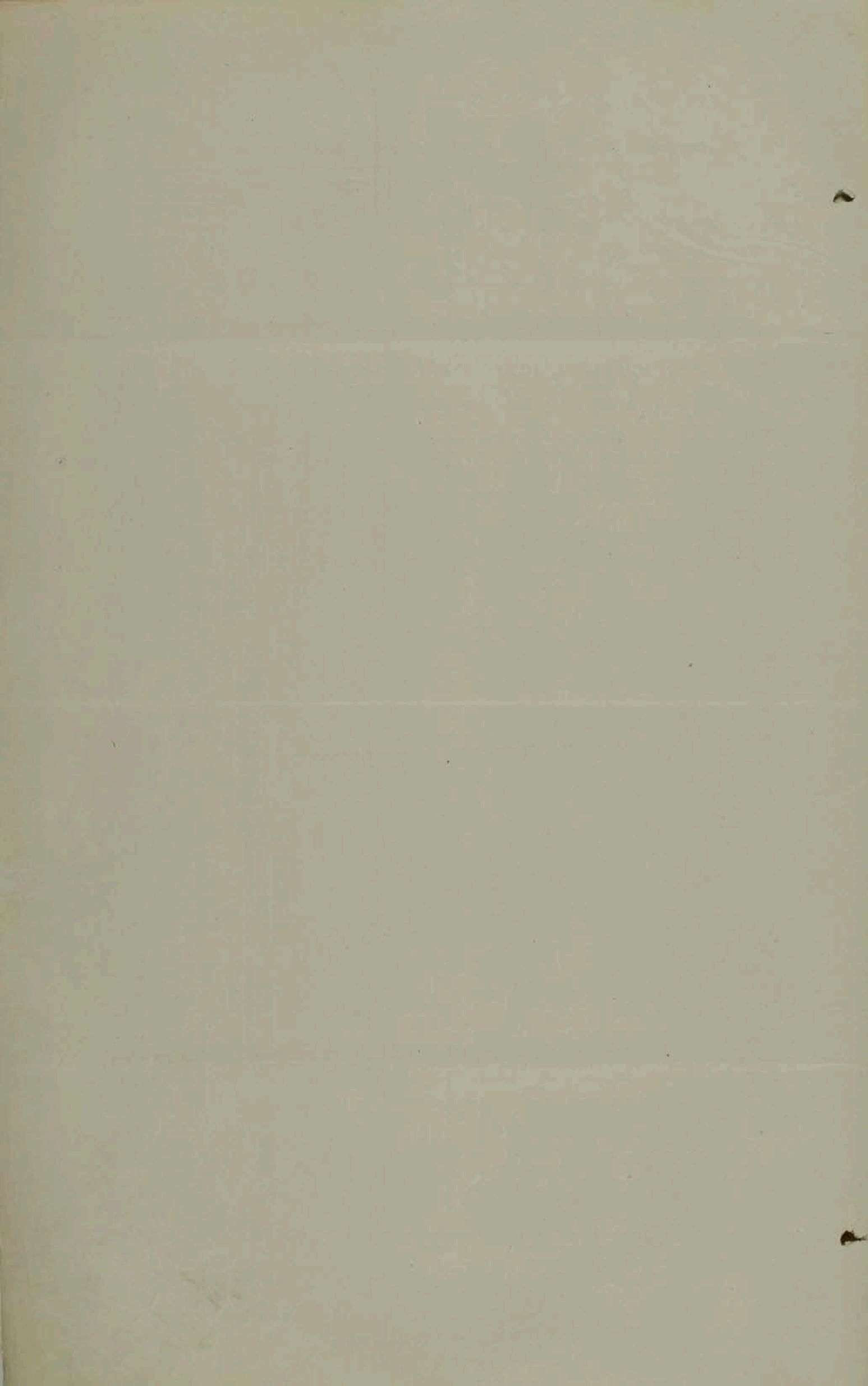
