# "Roko" Edge Belt.

Awarded First Prize at the  
Coolgardie Exhibition, 1899.

This Belt is so simple in construction as to at once commend itself to users on account of its complete unity when woven.

This Belt has been thoroughly tested for down driving for Mules—one of the most severe tests for any Belting—and has been found to work admirably.

We beg to draw the special attention of all Manufacturers, Merchants, and Users of Steam Power generally, to the above Patent Belt, which, by its combination of the many qualities to be found in manufactured Belts, cannot fail to meet a long-felt want in the market for a Belt which—while possessing the gripping power and great strength of ordinary Hair Belting—has a perfectly safe and solid edge. This edge, from the nature of the material used and the manner of weaving it into the side of the Belt, becomes impervious to the influence of the guide forks in running.

The Special Material, which forms the safe edge in the weaving of the Belt, takes the place of the outside ends in the warp and so becomes drawn—by alternate picks from the shuttle—and firmly embedded into the sides of the Belt, leaving about a quarter of an inch projecting from the edge of the Hair, which, when it becomes hard, forms a perfect safe edge to the Belt.

The Hair Belt is sufficiently well known to users for its strength, durability, and driving power to require no mention here, though it has hitherto lacked the Indestructible Edge which this now gives to it.

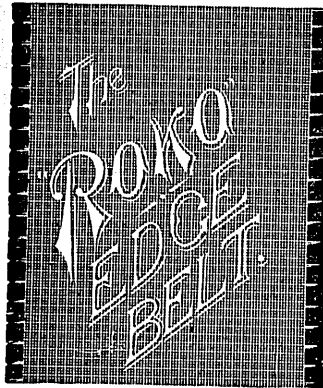
