The Lodge was consecrated on 17 July 1957 at the Masonic Hall, Forrest Street, South Perth by the Pro Grand Master, M.W. Bro. Dr. J.L. Rossiter, C.B.E., M.A., Litt. D. The Lodge amalgamated with South Perth Lodge no. 99 WAC on 17 October 1990.
