

WEST AUSTRALIAN HOUSEWIVES ASSOCIATION (INC.)

The inaugural meeting of the West Australian Housewives Association (Inc) was held on 10 March 1920 "for the purposes of protecting the interests of all housewives." The impetus for the formation of the association in Perth was predominantly the shortage of sugar in Western Australia. In 1920 the association asked the Perth City Council to establish Kerbstone Markets in the city, and as a result of the success of these markets others were opened throughout Perth. The association also formed branches in towns such as Kalgoorlie and Bunbury. The final meeting of the Executive was held on 3 April, 1984.
