

BUDDEE, PAUL EDGAR. 1913-2002

Paul Edgar Buddee was born at Perth, Western Australia on 12 March 1913. Educated at Claremont Teachers College and University of Western Australia. He taught in Western Australian schools until 1976, in the later period as a Headmaster. Buddee had studied music from an early age and became known as a concert flautist and composer. Writing was an additional career from the 1930's when he began writing for newspapers and published his first children's books. After serving in North Africa in the AIF during World War 2, he returned to teaching and writing, and has published a number of books, including children's stories, poetry and history. Buddee had a particular interest in researching Parkhurst Boys and he wrote "Fate of the Artful

Dodger". He donated his research materials to the State Library.

The Parkhurst boys were juvenile offenders' from Parkhurst Prison on the Isle of Wight, who were sent out to the Australian and New Zealand colonies between 1842 and 1861. Under the scheme, the boys were to be granted pardons under certain conditions mainly, permanent exile from Britain and, for younger boys, undertaking apprenticeships in the colonies. 1,499 boys are recorded as having been sent to the colonies, where, particularly in New Zealand, the scheme was seen by some as de facto convictism. In Western Australia however, the need for labour at that time appears to have made the young exiles acceptable.
