

FREMANTLE GAS AND COKE COY LTD

It is thought that a Mr RS Newbald started the original gas works in Cantonment Street. In 1885 a decision was made to float a limited liability company to take over the original works. The prospectus was published 29 July 1885 and the first meeting of provisional directors was held at the Emerald Isle Hotel Fremantle on the 31st August 1885. The Fremantle Gas and Coke Company Limited and the City of Perth Gas Company took steps to remove a major obstacle to their growth by an Act of Parliament which allowed the gas companies to enter private property and to take up the roads and footpaths to lay mains. The Bills relating to the act were assented to, on 16 September 1886. The plant at Spearwood was opened during 1953 and moved to O'Connor in 1976. In October 1986 the State Government purchased the company from its new owner Yosse Goldberg with the assistance of Laurie Connell.
