

**MARRIAGE GUIDANCE COUNCIL OF WESTERN AUSTRALIA INC.**

This body opened its first branch in Perth in June 1954, and then country branches at Kalgoorlie, Esperance, Pilbara and Bunbury. In 1966 the service had grown to the stage of employing a full time Director.

The Marriage Guidance Council services are provided by volunteers who undergo a three year training programme. The Council also provides a referral service to professional people, such as lawyers, doctors and psychologists, if necessary. The purpose of the service is to guide people about to be married, and people experiencing difficulty in married life. Discussions, lectures and counselling activities are provided.

The Council changed its name to Relationships Australia (Western Australia) in 1993-4.
