

MARITIME WORKERS UNION OF WESTERN AUSTRALIA

Prior to 1952 the Maritime Workers Union was called the Coastal Docks Rivers and Harbour Workers Union. In 1952 this union was deregistered and the state branches of the Seamen's Union and the Miscellaneous Workers Union where established. Later in approximately 1955 the Federated Ship Painters and Dockers Union, Western Australian branch, was established. In 1968 Shipwrights and Waterfront watchmen returned to the Union.

1971 the name of the union is changed to the Maritime Workers Union.

Then in 1987 the Maritime Workers Union amalgamated with the Seamen's Union of Australia on a federal level.
