In 1902, seven major saw-millers merged with the Millar organisation to form Millar's Karri and Jarrah Company and in 1910 the new company was operating 26 sawmills, 350 miles of railway, 3 shipping ports, over 1,000 horses and 40 locomotives. 1,500.000 acres of forest country was under its control.

In 1912 the name was changed to Millar's Timber and Trading Company Limited. The Inchcape Group took control of the company, then named Millar's (W.A.) Pty Ltd. in 1972.
