

SWAN BREWERY COMPANY (NT) PTY LTD

The Stuart Brewery in Darwin was established by the Swan Brewery. Various hotels in the Northern Territory were either purchased or built by the company. For example, the rebuilt Crossways Hotel in Katherine was opened in 1970. Swan Brewery Company (NT) Pty Ltd. was established as the parent company for Northern Territory operations.
