

## **KALGOORLIE BREWING COMPANY**

The Kalgoorlie Brewing and Ice Company opened in Kalgoorlie in 1896. In 1943 it was taken over by the Swan Brewery and changed its name to Kalgoorlie Brewing Company. The Brewery operated in Kalgoorlie and Merredin until 1982, when it was dismantled following Alan Bond's takeover of the Swan Brewery.
