

SAN MIGUEL AND SWAN HOLDINGS LTD

In 1972, the Swan Brewery Co Ltd combined with the San Miguel Corporation to make a takeover bid for Territory United Brewery Ltd, a New Guinean brewer. This became San Miguel and Swan Holdings Ltd. Due to poor returns on investment, they sold their interest in the company in 1974.
