

KWINANA. UNITING CHURCH

The records of this church show that it has operated under a number of names. The Presbyterian Church of Medina 1954-1961 later became known as the Uniting Free Church, Medina from 1962 to approximately 1967. The Methodist/Presbyterian Church of Kwinana was active in 1969. The Congregational/Methodist/Presbyterian Church of Kwinana was active from 1970 until the foundation of the Uniting Church, Kwinana in 1977.
