

DAY BREAK CAMP FARM. UNITING CHURCH

Situated 73 km east of Perth along Great Eastern Highway halfway between Bakers' Hill and Clackline on de Castilla Rd, in hills farming land. Comprising a 148.5 acres, with about 50 acres natural bush and 98 acres of pasture. The aim of the campsite was to care for people, nature and property. The site was closed and the property sold in 2004.
